A Plant Inspection was conducted at your Asphalt Plant located in Newark, NJ and has been found to be in compliance with New Jersey Department of Transportation Specifications. This acceptance is contingent on your ability to continue to meet all requirements and compliance with periodic inspections throughout the approval year. In addition, you are responsible for maintaining Quality Control Files at each plant location, to keep Scale/Gyratory/Ignition Oven calibrations current, to maintain Fire Extinguisher(s), to maintain & update as necessary a dedicated computer & printer, and to maintain a clean working laboratory/office/sanitary facilities. All Asphalt delivery tickets must be certified by a Weighmaster.

The Quality Control Plan you submitted for your plant located in Newark, NJ has been found to be in compliance with New Jersey Department of Transportation Specifications. Quality Control Plan requirements are not to be considered a complete overview of your manufacturing process, but rather minimum guidelines. This plan must be used for all work covered by NJDOT Specifications which includes Local Government work. You must have a certified SAT Level 2 Technician at your plant for all work requesting State Approved Asphalt Mix Designs. Material produced must be tested in accordance with your Quality Control Plan. Sampling and testing by your personnel should be done at the rate indicated within your Quality Control Plan for all materials receiving State Funds. Records are required to be maintained at each approved plant location. Quality Control Plans may need adjustments as problems arise. Please feel free to make these adjustments as this is a 'living' document. If changes are made, forward (2) revised originals to this office for review and approval.

The enclosed Master Copy's (LB-325's) have been found acceptable for use on Departmental Projects during the 2019 Construction Season. This approval is contingent on your ability to maintain the same conditions we find acceptable to grant your annual plant approval.
